ERNEST ARYEETEY is Director of the Institute of Statistical Social and Economic Research at the University of Ghana, Legon. His research focuses on the economics of development, with a particular emphasis on the role of institutions. He holds a doctorate in economics from the University of Dortmund, Germany.

MARK CHANDLER is an Assistant Professor of Economics at the Stockholm School of Economics in Riga, Latvia. He works on intergovernmental grants, fiscal federalism, the shadow economy, municipal finance and local public finance.

HADI SALEHI ESFAHANI is Professor of Economics and Director of Center for South Asian and Middle Eastern Studies at the University of Illinois at Urbana-Champaign, USA. In addition, he currently serves as the Editor-in-Chief of the *Quarterly Review of Economics and Finance* and President of Middle East Economic Association. He holds a PhD in economics from the University of California at Berkeley, USA, and his research interests include the political economy of development policies.

JAN FIDRMUC is Senior Lecturer in Economics at Brunel University in London. He holds a doctorate in economics from Tilburg University in The Netherlands. His research focuses on migration, post-colonial economics, growth and political economy.

AUGUSTIN KWASI FOSU is Deputy Director, UN University-WIDER, Finland; honorary RDRC Research Fellow, University of California at Berkeley, USA; and honorary BWPI Research Associate, University of Manchester, UK. He holds a PhD in economics from Northwestern University, USA, and a BA with honors in mathematics and economics from Lawrence University, USA. Professor Fosú is also co-Editor of the *Journal of African Economies* (Oxford) and serves on the editorial boards of many other journals, including: *Journal of Development Studies*, *Oxford Development Studies*, *World Bank Economic Review* and *World Development*.

JULIUS HORVATH is Senior Economist at the Czech National Bank (CNB), Prague. His research focuses on economic growth, fiscal and monetary policy, markets, bank reform and microfinance. He holds a doctorate in economics from Tilburg University, The Netherlands, and is currently working on issues of political economy, reform in Central and Eastern Europe, institutional economics and migration.

GARY MCMAHON is an independent consultant working on the socioeconomic and environmental consequences of large mining operations in developing countries and evaluating the work of research networks. He previously worked for the World Bank and the Global Development Network and holds a PhD in Economics from the University of Western Ontario, Canada.

GOBIND NANKANI was the second President of the Global Development Network (2007–2009). He is a former Vice President for Africa at the World Bank, and prior to that was also the Vice President of the Bank's Poverty Reduction and Economic Management Network (PREM). He has held senior management positions in various regions and sectors across the Bank and he has also served, on leave from the World Bank, as an economic advisor to the Government of Ghana. He holds PhD and MA degrees from Harvard University, USA, and a BSc degree from the University of Ghana. He is now the Executive Director of the DFID International Growth Center.

GUR OFER is Harvey M. and Lyn P. Meyerhoff Professor of Soviet Economics at the Departments of Economics and Russian Studies, Hebrew University, Jerusalem, Israel. He holds a doctorate in economics from Harvard University, USA, and has published extensively on economic transition, the service sector and reforming planned economies.

SIDDIQUR OSMANI is Professor of Economics at the University of Ulster and holds a PhD in economics from the London School of Economics. His research focuses on poverty, health and human rights in South Asia.

RICHARD POMFRET joined the Department of Economics at the University of Adelaide in 1992, after work at the Johns Hopkins University School of Advanced International Studies, USA, Concordia University in Montreal and the Institut fuer Weltwirtschaft at the University of Kiel in Germany. Professor Pomfret has acted as adviser to the Australian government and to international organizations. In 1993 he was seconded to the United Nations for a year, acting as adviser on macroeconomic policy to the Asian republics of the

former Soviet Union. His research interests focus on economic development and international economics.

LYN SQUIRE is past president of the Global Development Network. After gaining his PhD from Cambridge University, he spent the majority of his professional career at the World Bank. He has served as Chief Economist of the Middle East and North Africa Vice-Presidency, Director of the Research Department and Director of the 1990 World Development Report on Poverty.

PETER WARR is the John Crawford Professor of Agricultural Economics and founding Director of the Poverty Research Centre at the Australian National University. He holds a PhD in Economics from Stanford University, USA, and has published extensively on economic issues in Southeast Asia, especially Thailand. His current research has focused on the determinants of poverty reduction in Thailand, using a general equilibrium framework, and studies of the relationship between poverty reduction and the sectoral composition of economic growth in India, Taipei, China and Southeast Asia.
