**Scott T. Allison** is Professor of Psychology at the University of Richmond, Virginia. His research areas include heroism, villainy, and heroic transformation in organizations. His most recent articles and books on heroism draw extensively from the seminal work of Joseph Campbell.

**Douglas Bradburn**, Founding Director of the Fred W. Smith National Library for the Study of George Washington at Mount Vernon, Virginia, is an expert on the history of the American Revolution and the Founding. In addition to administering George Washington's Presidential Library and the research mission at Mount Vernon, he also coordinates the development of Leadership Education at Mount Vernon and designs programming for student, corporate, military, and non-profit groups who approach the problem of leadership from the perspective of George Washington and the American Founders. Before joining Mount Vernon, Bradburn served as associate professor and vice-chair in the history department at SUNY-Binghamton University.

**Joanne B. Ciulla** holds the Coston Family Chair in Leadership and Ethics at the Jepson School of Leadership Studies, University of Richmond. Her PhD is in philosophy, and she publishes extensively on leadership ethics. Her books include *Ethics, the Heart of Leadership* (3rd edition) and *Leadership Ethics*, a co-edited three volume reference set in the Sage Benchmarks in Leadership series.

**Richard A. Couto** is Distinguished Senior Scholar of the Union Institute's Ethical and Creative Leadership PhD program and formerly served as a founding faculty member at both the University of Richmond's Jepson School of Leadership Studies and the PhD Program in Leadership at Antioch University, Ohio. His research and practice focused on community and social movement leadership. His most recent work, the two-volume edited work *Political and Civic Leadership: A Reference Handbook* (Sage, 2010), won the Outstanding Book Award for Scholarship, 2012, from the International Leadership Association.

**Thomas E. Cronin** is McHugh Professor of American Institutions and Leadership at Colorado College and President Emeritus at Whitman College (1993–2005). He is co-author of the prize-winning *Leadership Matters* (Paradigm, 2012), co-author of *The Paradoxes of the American Presidency* (5th edition, Oxford University Press, 2017), and was for three decades a co-author with James MacGregor Burns and Jack Peltason of the best-selling American politics text *Government by the People*.

**Susan Dunn** is the Massachusetts Professor of Humanities at Williams College, where she teaches in the Leadership Studies program, founded by James MacGregor Burns and George R. Goethals. She and Burns co-authored *The Three Roosevelts* (2001) and *George Washington* (2004). Her most recent books are *Dominion of Memories: Jefferson, Madison and the Decline of Virginia* (2007), *Roosevelt's Purge* (2010), and *1940: FDR, Willkie, Lindbergh, Hitler—the Election Amid the Storm* (2013).

**George R. Goethals** holds the E. Claiborne Robins Distinguished Professorship in Leadership Studies at the University of Richmond, Virginia. For many years Goethals worked with James MacGregor Burns in establishing a Leadership Studies program at Burns's *alma mater*, Williams College. His recent book, *Presidential Leadership and African Americans: 'An American Dilemma' from Slavery to the White House* (2015), reflects the influence of Professor Burns.

**Gill Robinson Hickman** is currently a professor emerita in the Jepson School of Leadership Studies at the University of Richmond. She has held positions as dean, Professor of Public Administration, and human resource director. Her books include *Leading Organizations: Perspectives for a New Era* (3rd edition, 2016), *The Power of Invisible Leadership* with co-author Georgia Sorenson (2012), *Leading Change in Multiple Contexts* (2009), and *Managing Personnel in the Public Sector: A Shared Responsibility* with Dalton Lee (2001). Dr. Hickman's current research and book projects focus on leading change, leadership in socially active businesses, and invisible leadership.

**Edward J. Larson** is Hugh and Hazel Darling Chair in Law and University Professor of History at Pepperdine University, California, and was a student of James MacGregor Burns at Williams College. The author of 11 books and over 80 published articles, he received the 1998 Pulitzer Prize for History for his book *Summer for the Gods: The Scopes Trial and America's Continuing Debate Over Science and Religion*. His latest book is *The Return of George Washington: Uniting the States, 1783–1789* (2014).

**Georgia Sorenson** is Møller By-Fellow and Leadership Scholar at Churchill College, University of Cambridge. She founded the James MacGregor Burns Academy of Leadership, now housed at Cambridge. She is also co-founder of the International Leadership Association. An architect of the leadership studies field, she was awarded 2015 International Leadership Association's Lifetime Achievement Award, an award that honors an individual's accomplishments in the development and enhancement of the field of leadership over his or her lifetime.

**Patrick Spero** is Librarian of the American Philosophical Society in Philadelphia. Formerly Assistant Professor of History and Leadership Studies at Williams College, Spero was the first faculty member hired specifically to teach in the Williams Leadership Studies Program, a program inspired by the scholarship of James MacGregor Burns.
